4. Provide an example when you were able to prevent a problem because you foresaw the reaction of another
person.
5. Share an experience in which you effectively assessed patients' pain levels and sedation requirements.
6. Please share with me an example of how you helped coach or mentor someone. What improvements did
you see in the person's knowledge or skills?
7. Provide an example of when you set expectations and monitored the performance of subordinates. What
guidance and direction did you find most effective?

respect, and cooperation.)
